Neither my submission of the material nor RNR's review of the Proposal creates an implied-in-fact or implied-in-law contract, even if that is an industry practice.

I release Real-N-Reel Films, its employees, and anyone acting on its behalf from all present and future claims of any kind, known or unknown, arising from or related to the Proposal/Script/Treatment. I agree that I will never make any claim or demand or bring any action against RNR in connection with the use or alleged use of the material and expressly waive all such claims. I acknowledge that there may be facts relevant to this Submission Agreement that I am not currently aware of, and I hereby waive my right to assert any claims arising from or related to such unknown facts. I further agree to abide by the laws of Canada.
7. This Submission Agreement is compliant with the laws of the province of Ontario, regardless of conflict of law principles. I have read and fully comprehended the terms and conditions of this release and waiver and understand that I have given up substantial rights by signing it.
